POLICY STATEMENT

The Bunbury Wildlife Park is committed to providing exemplary care to the animals in its care through the effective use of the Five Domains model of animal welfare.

POLICY SCOPE

This Policy will apply to all persons who are engaged to perform duties involving animal interaction at the Bunbury Wildlife Park.

POLICY DETAILS

This Policy serves as a commitment by the City of Bunbury and specifically the Bunbury Wildlife Park to provide a positive animal welfare state for all species in its care.

The Bunbury Wildlife Park seeks to set a leading standard in the Bunbury Geographe and South West regions of Western Australia for husbandry and exhibit design that balances the needs of animals, staff and visitors.

The Bunbury Wildlife Park will use the Five Domains model to ensure the wellbeing of its captive species. These are:

| 1. Nutrition: | Appropriate consumption of not only nutritious food but also physical delivery requirements |
| 2. Environment: | Consideration of species specific environmental requirements, whilst also taking into account public expectations (e.g. visibility) and logistical constraints (e.g. finances) |
| 3. Health: | Proficient keeping staff with high husbandry standards, access to veterinary care, preventative medicine programs and geriatric care |
| 4. Behaviour: | Diverse environmental conditions where appropriate, enrichment programs and skilled interpretation and monitoring of behaviours |
