Outcome of Meeting 10 August 2023

A procedural motion pursuant to Standing Order 11.1(h) that the meeting be closed to the public was moved by Cr Giles and seconded by Cr Andrew

The Mayor put the motion to the vote, and it was adopted to become the Council's decision on the matter.

Council Decision 144/23

That Council pursuant to Standing Order 11.1(h) close the meeting to the public to deal with item 7.1 Chief Executive Officer Recruitment.

CARRIED UNANIMOUSLY 12 votes "for" / Nil votes "against"

Councillor Ghasseb made the following declaration of confidentiality:

I, Cr Ghasseb, declare that pursuant to regulation 14CA(5) of the Administration Regulations, I will be able to maintain confidentiality for the duration of any closed part of the Council Meeting to be held 10 August 2023.

The meeting was closed to the public at 5:35.

A motion to suspend all standing orders to facilitate discussion was moved by Cr Steck and seconded by Cr Andrew. The Mayor put the motion to the vote and it was carried 10 votes "for" to 2 votes "against". Voting "for" was the Mayor and Councillors Andrew, Ghasseb, Giles, McCleary, Smith, Steck, Steele, Turner and Yip. Councillors Kozisek and Quain voted "against".

Councillor Ghasseb moved a motion to defer consideration of this item however it lapsed as there was no seconder.

Councillor Ghasseb left the meeting at 6:35pm and did not return.

The executive recommendation (as printed) was moved by Cr Turner and seconded by Cr Kozisek.

The Mayor put the motion to the vote, and it was adopted to become the Council's decision on the matter.

Council Decision 145/23

That Council, in accordance with City of Bunbury Standards for Chief Executive Officer Recruitment, Performance and Termination:

- 1. Ratify the CEO Recruitment Panel's recommendation of its preferred candidate and second preferred candidate as contained in Confidential Attachment 1.
- 2. Approve the draft template contract of employment and terms therein as presented in Confidential Attachment 8.
- 3. Authorise the Mayor and Recruitment Consultant to negotiate specific contract terms with the preferred candidate based on the contract template approved at point 2.
- 4. Require that any negotiated changes to the adopted contract as per Confidential Attachment 8 be presented to Council for consideration as per Clause 12 of the Standards.
- 5. Agree that in the event of the preferred candidate withdrawing their application at any time, that the Mayor be authorised to make an offer of employment to the second preferred candidate, and that points 2-5 of this resolution would be applied to the second preferred candidate.

CARRIED UNANIMOUSLY 11 votes "for" / Nil votes "against"

Councillor Smith moved, and Cr Steele seconded a motion to thank the Director Strategy and Organisational Performance as below. The motion was carried unanimously as below.

Council Decision 146/23

That Council thank Karin Strachan, Director Strategy and Organisational Performance for coordinating the Chief Executive Officer Recruitment Process.

CARRIED UNANIMOUSLY 11 votes "for" / Nil votes "against"

A motion was moved that the meeting be reopened to the public however the mover and seconder to this motion were not recorded in the absence of any administrative support for the confidential part of the meeting.

- 3. Authorise the Mayor and Recruitment Consultant to negotiate specific contract terms with the preferred candidate based on the contract template approved at point 2.
- 4. Require that any negotiated changes to the adopted contract as per Confidential Attachment 8 be presented to Council for consideration as per Clause 12 of the Standards.
- 5. Agree that in the event of the preferred candidate withdrawing their application at any time, that the Mayor be authorised to make an offer of employment to the second preferred candidate, and that points 2-5 of this resolution would be applied to the second preferred candidate.
