#### **Background**

The City of Bunbury Grant Program is an annual initiative designed to position Bunbury as a premier cultural and creative destination where people can connect. The program includes three funding categories: Community Connect, Signature Events, and Active Places, ensuring a diverse range of projects and initiatives receive support.

The 2025/26 Grant Program will open on 21 April 2025 and close on 30 May 2025.

To ensure the program remains effective, responsive, and aligned with community needs, it is reviewed annually. This review process incorporates best practice principles and benchmarking against similar-sized regional Local Governments.

These updates position the City of Bunbury Grant Program in line with industry best practices and benchmarking against similar regional grant programs.

The City's annual Grant Program continues to support a diverse range of new and existing events that contribute to Bunbury's vibrant community. However, 2024 presented several challenges for the local event landscape, particularly for major music festivals and community events.

Key challenges included:

- Major music festivals such as Wild West Fest and You & Me Festival were cancelled due to insufficient ticket sales.
- *Groovin the Moo*, a longstanding national event, announced via social media that it will not be returning, with a review of the event format underway.
- Community events were also impacted, Bunbury Show, and *Bumpers and Beats* cancelling their event due to a scheduling conflict with the pre-season AFL game between North Melbourne and the West Coast Eagles.

Despite these setbacks, the City remains committed to supporting events through its Grant Program, ensuring Bunbury continues to be a destination for cultural, sporting, and community events.

To address these challenges, the City continues to support community groups by providing workshops that enhance their capacity and explore sustainable event models. These initiatives aim to equip event organisers with the knowledge and resources needed to overcome financial and logistical hurdles.

Upcoming Capacity-Building Initiatives include:

#### **Grants Expo**

The City's annual Grants Expo will be held on 30 April 2025, from 9:00AM – 1:00PM at Mantra Lighthouse Hotel. This event is designed to connect community groups with external funding sources that can support their initiatives.

Additionally, the City has secured sponsorship from Workforce Australia Local Jobs – South West to provide a free grant writing workshop for community groups on the day, delivered by Whitney Consulting.

#### Inclusive Events and Social Inclusion & Disability Awareness Workshops

In collaboration with the Community Development Team, the City will deliver annual workshops focused on accessibility and inclusion. These sessions will assist event organisers in planning, developing, and delivering events where all members of the community feel welcomed and included.

#### **Analysis of Financial and Budget Implications**

The cancellation of the abovementioned events resulted in \$112,000 of funds returned to the City. These funds were redistributed as a one-off contribution to the Sports Marketing Australia program and round 2 of the Grant Program.

#### **Background**

The City's Place Activation Team supports events that activate our city and creates a vibrant, prosperous and connected community.

Since the recent organisational restructure, the team has undergone some changes in their service delivery, and offers the following services:

- 1. **Attract:** We attract major sporting, arts and cultural events that promote Bunbury as an events destination.
- 2. **Facilitate:** We facilitate activity/events and commercial film approvals, to ensure those held on City of Bunbury owned spaces are successful and compliant.

- 3. **Provide:** We provide funding opportunities to support community driven initiatives that enrich our community.
- 4. **Deliver:** We deliver the City's flagship events, Christmas in the City, Sky Fest Australia Day Celebrations and Summer Lovin' campaign, in partnership with the community, to increase connection and ownership.
- 5. **Build:** We build capacity through delivery of workshops to ensure our community produce high quality and compliant events.
- 6. **Support:** We support international engagement opportunities with Bunbury's Sister and Friendship Cities to foster a prosperous community.

#### **Officer Comments**

The following is an update of programs and activities currently underway in the Place Activation portfolio.

#### Summer Lovin Campaign

The Place Activation Team launched its Summer Lovin' campaign last December. The two-month campaign aims to activate the CBD and iconic waterways, by offering a vibrant calendar of events for residents and visitors to enjoy. The campaign influenced more traffic and vibrancy into the city centre, by at least 99,941, according to approximate figures provided by event partners and City owned events, indicating the campaign's wide-reaching impact. This year, the campaign welcomed 18 partners, showcasing a variety of activities on offer in the CBD to our community.

#### Christmas in the City

Christmas in the City 2024 was a thriving success, despite the challenges faced throughout the year, with only one part-time staff member working on the event from August 2024 until the new full-time replacement staff member commenced in mid-October 2024.

The event showcased the community's ability to come together and celebrate the start of the festive season in an inclusive environment. The Place Activation team demonstrated remarkable dedication in executing the event, building on valuable feedback from previous years to create new opportunities for growth and improvement.

While there were a few setbacks, such as a decrease in in-kind support and the need for further engagement with local businesses, the event achieved significant milestones. These include the introduction of themed activities, a stronger collaboration between departments, and the incorporation of diverse cultural experiences. Additionally, the successful partnership with Lotterywest and other funding bodies helped boost the event's resources, ensuring that it could continue to provide free, accessible and inclusive activities for all attendees.

The event's new branding also resonated with attendees, establishing a refreshed identity for Christmas in the City that will help attract even more people in the future. Looking ahead, there is ample opportunity to continue building on this foundation, with future events expected to

benefit from stronger sponsorships, more creative participation, and improved event logistics. Christmas in the City 2024 demonstrated the importance of community engagement, effective collaboration, and continued innovation, ensuring its place as a key annual event for the City of Bunbury.

#### **SkyFest Australia Day Celebrations**

This year's SkyFest was a huge success, with around 40,000 people coming together to celebrate on the Koombana Foreshore. With a renewed event purpose "Connecting our community to celebrate Boodja 'country' and what it means to be Australian", the focus on reconciliation efforts exceeded expectations. From the ochre painting and autograph signing with Lewis Jetta, to the Noongar arts, stalls, and stage programming with Noongar representation. The event strongly achieved the City's Strategic Community Plan goals of "Promoting Noongar Culture".

The event received fantastic feedback, with many saying it was one of the best SkyFest's they have seen held in the area. Crowds were treated to a range of incredible performances and activities, including the Spare Parts Puppet Theatre's String Symphony, which brought a magical energy to the festival. Over on the beach, Kite Kinetics' display filled the sky with colour, creating a stunning backdrop for the event. There was also plenty of excitement around the meet-and-greets with Lewis Jetta and Tony Galati, who were a hit with eventgoers.

From an operational perspective, the event layout worked really well, making it easy for people to move through the space and enjoy everything on offer. The shuttle buses were well used, helping attendees get to and from the event smoothly. As always, the fireworks display was a major highlight, drawing the biggest crowd of the night. A huge thank you to Spudshed, the naming sponsor for the fireworks, for helping make it happen. With such a great response from the community, the Place Activation Team are already looking ahead to making next year's SkyFest even better.

#### Sports Marketing Australia

The City of Bunbury's partnership with Sports Marketing Australia (SMA) continues to be a strategic and impactful investment, significantly contributing to the city's economic growth, community engagement, and overall appeal as a premier events destination.

Since the last BEAC meeting, the City recently hosted the following events:

In summary, the City of Bunbury invested \$44,500 to host five State and National events, which activated Bunbury over 10 days between November 2024 and February 2025. These events successfully attracted visitors to the region and contributed to the local economy.

#### Key outcomes include:

- 2,570 visitors from outside the region attended these events.
- 83% of event participants travelled from outside the region.
- The total economic impact generated by these events in Bunbury was \$6,869,283.

  This investment has demonstrated a strong return, reinforcing Bunbury as a premier destination for major events and supporting local businesses through increased tourism and economic activity.
